

ONE2ONE – Conditions

To purchase a car through DB Trading, the following terms apply:

You find the vehicle

- Send the link to the car advertisement to **sales@db-trading.dk** or directly to your contact:
 - Thor: thor@db-trading.dk.
 - Philip: philip@db-trading.dk
- We aim to provide all relevant information about the vehicle within a few hours.
- You approve the vehicle, and we purchase it.

Claims

If defects or faults beyond what has been described (and beyond the deductible) occur, these must be reported to DB Trading no later than **48 hours after** receipt. Documentation in the form of pictures, description, and any repair cost estimate must be provided. DB Trading is not liable for damages, but we will always do our best to help resolve the issue.

DB Trading finds the vehicle

- The vehicle is selected from DB Trading's network, possibly via a sales list.
- All relevant information about the vehicle will be obtained.
- The vehicle is approved, and the price is agreed upon.

Claims

If defects or faults beyond what has been described (and beyond the deductible) occur, these must be reported to DB Trading no later than **48 hours after** receipt. Documentation in the form of pictures, description, and any repair cost estimate must be provided.

Scratches that can be polished and stone chips that can be repaired with touch-up paint are considered minor issues and are not subject to reimbursement.

Claims - Generelt

DB Trading is not liable for any hidden defects or faults not acknowledged by the seller.

Pricing

- 2% of the vehicle's net price, minimum DKK 12,000 including transport.
- Negotiated discounts when "You find the vehicle" are split **20/80 in your favour**.

The **net price** is the vehicle's price excluding VAT and registration tax.

An additional transport fee may apply for cars north of Stockholm or for special transport requirements in Southern Europe.

Delivery

All cars are delivered within approximately **15 working days** after confirmation from the supplier. In case of later delivery, a weekly written update on the expected delivery will be provided.

Vehicle documents

- Vehicle documents such as COC (Certificate of Conformity) and registration certificate will be handled by DB Trading. The documents will be sent by post.
- The COC may be inside the vehicle. If it is not included, it must be purchased separately. We use EUROCOC, and the price is approximately €250 depending on the vehicle. Delivery time is around **3–5 days**. Shipment is by courier and charged at DKK 200 + VAT.

Transport

Vehicles are delivered to the buyer's address. Unless otherwise agreed, transport costs will be included in the purchase price.

Deductible

In addition to the described faults and defects, there will be a deductible per vehicle of **€500 or DKK 3,750**. These amounts are excluding VAT.

Cancellation

It is **not possible to cancel** a purchase once an agreement has been made.

Dealer – Vehicle model

DB Trading reserves the right to refuse certain dealers and vehicle models.

Payment terms

Vehicles must be paid for at the time of order. After acceptance of the purchase, an invoice will be issued and must be paid in full immediately.
